ABSENTEE BALLOTS

Absentee ballot applications are now available at the City Clerk's Office. The deadline to apply for an absentee ballot is **MONDAY, NOVEMBER 4TH** at 12 Noon. Please call the City Clerks' Office for further information. The following link will give you instructions from the Secretary of State's Office on the absentee ballot process, and a link to downloading an application.

There are two ways to vote by absentee ballot. One; the voter can cast an absentee ballot in person at the City Clerk's Office on or before the deadline as stated above.

Two, by a signed, written request in the form of an AB application or letter in writing. The absentee ballot must be mailed to the voter (SAID BALLOT CANNOT BE HAND CARRIED OUT OF THE OFFICE). A family member residing in the same household can request an absentee ballot on behalf of a voter residing in the same household by filling out an "Absentee Ballot Application by a Family Member".

DO NOT WAIT UNTIL THE LAST MINUTE IF YOU WISH TO HAVE AN ABSENTEE BALLOT MAILED, ESPECIALLY, FOR THOSE VOTERS AT SCHOOL OR OUT OF STATE.

The deadline to register to vote or change your voting address for the November 5th election is **WEDNESDAY, OCTOBER 16TH**. The City Clerk's Office will be open until 8:00 p.m. Please call the City Clerk's Office to inquire on your voter status.
