- 3) Mulch, sand, salt and other bulk materials stored on the site must be managed so as to prevent nuisance conditions, including the migration of odors and dust, to other properties or serving as an attractant or harborage for rodents. On-site mulch storage will not exceed 200 yards. Mulch, sand, salt and other bulk materials stored on the site must be contained so as to prevent spread of such materials under all weather and potential flood conditions;
- 4) Trash and refuse shall be maintained in a dumpster on site;
- 5) The site is to be surrounded by a six (6) foot high sight-impervious fence;
- Hours of operation shall be 6:00 AM to 10:00 PM, except during snow storms at which time 24hour access shall be allowed; and
- 7) There shall be no parking on the right of way that is owned by the industrial condominium located at the end of Birney Street and identified as Industrial A, Assessors Map 95, Parcels 800-808.

LEGAL AFFAIRS COMMITTEE FEBRUARY 12, 2015

P86-15 COUCILLOR OSBORNE – Reporting for the Legal Affairs Committee – The Legal Affairs Committee met this evening with myself as chair; present with Councillor Garabedian, Councillor Gravel, Councillor McGinn, Councillor Gould sat in for Councillor Moutsoulas, also present were Councillor Saslaw and Councillor Walsh. The first was a discussion on a complaint filed by Dana Roby, Trustee of DJR Realty Trust, who is the owner of 195 Washington Street regarding one of their tenants, P.K. Motor Cars, Incorporated. And the discussion determined what action the council should take on some allegations made by Mr. Roby that the Special Permit application made by P.K. Motors may have been issued fraudulently because alleged forgery of Mr. Roby's name on the application and the possibility of rearranging the lines of a stamped plan submitted with the Special Permit. The discussion was quite lengthy and it was determined that we would really have no way to know that. There was a motion from Councillor Gravel. (Report received)

- f. Traffic;
- g. Parking;
- h. Terrorism Controls;
- i. Lodging/Accommodations; and
- j. Neighborhood Engagement.

Our goal is to protect the interests and safety of our Citizens and the ordinance should be constructed in a manner that places the burden of that goal on the organization that is conducting the event working in close cooperation with the City. (Unanimous)
