REPORTS OF COMMITTEE

LEGAL AFFAIRS COMMITTEE MAY 14, 2015

P313-15 COUNCILLOR OSBORNE – Reporting for the Legal Affairs Committee – Legal Affairs Committee met tonight; present was myself as Chairman, Councillor Walsh sat in for Councillor Garabedian, Councillor Gravel, Councillor McGinn, Councillor Moutsoulas, Councillor Gould sat in for a little while for Councillor Moutsoulas, Councillor Manning-Martin, and Councillor Saslaw. The first order of business was status of the number of Class 2 Motor Vehicle Licenses. We got a report from the City Clerk that there is, according to our ordinance, a 52-license limit in the city of Peabody, 49 of which are active. So there are three remaining licenses within the city. The next order of business was posting at a business the Class 2 Motor Vehicle License with the number of vehicles that are allowed on the lot. State law requires that they be posted prominently at the location of the business. Councillor Walsh made the following motion. (Report received)

P314-15 COUNCILLOR OSBORNE – Reporting for the Legal Affairs Committee - MOVE to revise Section 16.29 of the Zoning Ordinance to state that a Class 2 Motor Vehicle License must be prominently displayed on the front door of the business; and to request that the City Clerk increase the font regarding the number of vehicles on the license. (Unanimous)

P315-15 COUNCILLOR OSBORNE – Reporting for the Legal Affairs Committee - The next order of business was a communication from Assistant City Solicitor Adam Buckley regarding a council motion to designate a parcel of land off Lynnfield Street as conservation land. This came about as a request for the purchase of city-owned land from Mr. Rollins and Mr. Tusinski. At that time it was deemed that the city chose not to sell that parcel of land and it be turned over to the Conservation Commission. Mr. Rollins, when he investigated purchasing the land, saw that it is still on the Web site listed as the city of Peabody as the owner and again petitioned for the purchase of that land. At that time during that purchasing process Attorney Buckley could not identify a deed for the property. He did a search through the Registry of Deeds and could not identify a deed. So as a result we really don't know who the owner of the land is. Councillor Walsh made the following motion. (Report received)

P317-15 COUNCILLOR OSBORNE – Reporting for the Legal Affairs Committee - The next order of business was a review of the City Council Special Permit procedures. We got into a situation where we questioned whether a lot of Special Permits are properly before us, whether the signatures are true, and whether we can verify signatures so it was decided that this issue would stay in Committee and the Committee will set up a working session and invite the City Clerk, Julie Daigle and Karen Sawyer Conard from Community Development Department and revise the Special Permit process for the city. (Report received)

COMMITTEE OF THE WHOLE
MAY 4, 2015

P318-15 COUNCILLOR WALSH – Reporting for the Committee of the Whole – The City Council convened for a breakfast meeting along with our counterparts from the Salem City Council. Present from the Peabody City Council were Councillors: Moutsoulas, Gould, Garabedian, Gravel, McGinn, Driscoll, Sinewitz, and myself. Present from the Salem City Council were Councillors: Milo, Furey, McCarthy, O'Keefe, and Legault. Also present were Mayor Bettencourt, Mayor Driscoll, Karen Sawyer from our Community Development Department, and both police chiefs: Griffin and Butler. Several items were discussed; among them His Honor the Mayor talked about the renovations in the Peabody Square area and how it will affect both Peabody residents and the Salem commuters. Mayor Driscoll updated us on the Blubber Hollow construction and the progress on their Council on Aging project, which will be combined with a little bit of retail at the corner of Bridge Street and Boston Street. Councillor Gravel pointed out to all of us, along with the Salem City Council, the opportunities that will present themselves with the Senior Open coming to the city of Peabody at the Salem Country Club and what it will mean as far as a demand for hotel rooms and details as well. Councillor Legault from Salem brought up the issue of the Uber ride service and its impact on the local taxi businesses in Salem, Peabody, Beverly, and beyond. What was discussed was that the Uber rides are more focused towards the airport and there is a concern that the opportunity may not exist for some of our constituents who are trying to get to medical appointments and shorter rides, depending on how this whole Uber situation progresses. Councillor Sinewitz advised everybody about the Airbnb issue and the potential loss in hotel and motel taxes. Councillor O'Keefe from Salem discussed the possibility of looking into a joint fire station for Salem/Peabody, similar to the station that is located at the Revere/Malden line. Councillor Moutsoulas updated us on the history, I guess, of the traffic congestion in the City of Peabody. We, as a report of progress, agreed to meet again and work on several of the issues. I will stay in contact with the Salem Council President and hopefully we will end up with a couple working sessions out of this. I would like to extend my thanks to all of you for participating in this. (Report received)


UNFINISHED BUSINESS FROM THE PRECEDING MATTER

P357-15 COUNCILLOR GRAVEL – BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF PEABODY that two million dollars (\$2,000,000) is appropriated to pay costs of the Peabody Square Reconfiguration Project, so-called, including, but not limited to, engineering and design services, reconfiguring, constructing and reconstructing roadways, relocating existing structures and monuments, related lighting and crosswalk improvements and the relocating and upgrading of existing sewer and drain lines, and for the payment of any and all other costs incidental and related thereto; that to meet this appropriation the Treasurer, with the approval of the Mayor, is authorized to borrow said amount under Chapter 44 of the General Laws or any other enabling authority; that the total amount authorized to be borrowed by this Bond Order shall be reduced to the extent of any grants received by the City on account of this project, and that the Mayor is authorized to take any other action necessary or convenient to carry out the purposes of this Bond, and that said bond order be adopted as advertised and read. (Carried 10-0; Councillor Garabedian absent)

P358-15 COUNCILLOR GRAVEL - BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF PEABODY that the City appropriate the amount of Four Million Eight Hundred Fifty Thousand (\$4,850,000) Dollars for the purpose of paying costs of roof and window replacement of the Peabody Accelerated Repair Program, John E. McCarthy Memorial School at 76 Lake Street, Peabody, MA, 01960, including the payment of all costs incidental or related thereto (the "Project"), which proposed repair project would materially extend the useful life of the school and preserve an asset that otherwise is capable of supporting the required educational program, and for which the City may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the School Building Committee. To meet this appropriation the Treasurer with the approval of the Mayor, is authorized to borrow said amount under M.G.L. Chapter 44, or pursuant to any other enabling authority. The City acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any project costs the City incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the City; provided further that any grant that the City may receive from the MSBA for the Project shall not exceed the lesser of (1) 54.79 % of eligible, approved project costs, as determined by the MSBA, or (2) the total maximum grant amount determined by the MSBA; and that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement that may be executed between the City and the MSBA, and that said bond order be adopted as advertised and read. (Carried 10-0; Councillor Garabedian absent)
