OCTOBER 15, 2015

Special Meeting of the Peabody City Council was called to order by City Council President, Thomas P. Walsh.

A public hearing was duly held on the application from Spofford Automotive, LLC, 55-R Walnut Street, Peabody, MA. Appearing to speak on behalf of the application was Mr. John Spofford. No one appeared to speak in favor. No one appeared to speak in opposition.

P762-15 COUNCILLOR MOUTSOULAS – BE IT ORDERED by the City Council of the City of Peabody that the application from Spofford Automotive, LLC, 55-R Walnut Street, Peabody, MA, for a Special Permit for sale of automobiles at said 55-R Walnut Street, Peabody, MA, be approved, as filed in accordance with Sections 4.2.5, 6.1, and 15.7 of the Peabody Zoning Ordinance. Said decision is based on the following reasons and subject to the following condition:

Reason: Owing to the fact that the use as approved satisfies a desirable local need, that its design and appearance will not be injurious to the established or future character of the vicinity and the neighborhood, and that said approval is in harmony with the general purpose and intent of the Zoning Ordinance of the City of Peabody.

1. A maximum of two (2) motor vehicles.

Said decision is based on the following reasons.


