Order to Correct Violations Repeat Offense

Dear Mr. Panousos:

An investigation conducted by Inspector John Yale of the Peabody Health Department on 7-14-2020 of your property located at Giovanni's, 672 Lowell St., revealed the following nuisance condition, in violation of Massachusetts General Laws, Governor's Directive on Social Distancing and Face Coverings.

Description of Nuisance Condition	Timeframe for Compliance
Multiple complaints, 7-1-2020, 7-8-2020, 7-11-2020 have been received and discussed with the operators of Giovanni's regarding employees not wearing face coverings while in close proximity to others in the restaurant.	Immediately

Order to Correct: In accordance with Massachusetts General Laws, Chapter 111, section 123, you are hereby ordered to abate the nuisance within the timeframe listed. Follow-up reinspections will be conducted to determine your compliance with this Order.

Penalty for Failure to Comply with Order: Citation \$300.00. Failure to comply with the deadlines set out above may result in this agency initiating criminal or civil proceedings against you. Any person convicted of failure to comply with the order shall be subject to a penalty of up to \$1000 for every day during which he knowingly violates the order.

Right to a Hearing: You may request a public hearing before the Board of Health by filing with said Board within seven days after the day the order was served, a written petition requesting a hearing on the matter. At the hearing, you and any other affected parties will be given an opportunity to be heard and to show cause why the order should be upheld, modified or withdrawn. You also have the right to be represented, and to inspect and obtain copies of any inspection reports, orders, or other documents in the possession of the Board.

This inspection report is signed and certified under the pains and penalties of perjury.
